6th Jagiellonian Symposium on Advances in Particle Physics and Medicine (JS:2026) ("Rules")

Part 1: Conference Information Card ("Card")

I. General Information:

1. Conference Name: **6th Jagiellonian Symposium on Advances in Particle Physics and Medicine (JS:2026)** ("Conference")
2. Conference Date: July 5-11, 2026 ("Date")
3. Conference Venue: **Jagiellonian University - Collegium Nowodworskiego, ul. Św. Anny 12, Krakow** ("Venue")
4. Conference Organiser ("Organiser"): Jagiellonian University, ul. Gołębia 24, 31-007 Kraków, on whose behalf the activities related to conducting the Conference are performed by the organisational unit of the Faculty of Physics, Astronomy and Applied Computer Science of the Jagiellonian University.

10. Forms of participation in the Conference: active and passive (Participants presenting Presentations and Participants who are passive listeners may participate in the Conference).
11. Active Participants are Participants presenting a Presentation ("Speakers").
12. Rules for qualifying for participation in the Conference:
 - a) priority for participation in the Conference is given to those who have accepted the Organiser's invitation to participate in the Conference.
 - b) next, those who express their willingness to actively participate in the Conference will be qualified based on the selection of their submitted Presentation abstracts, according to the principles and criteria specified in Section II of the Charter.
 - c) subject to availability within the space limit, Participant status may also be granted to those who express their willingness to passively participate in the Conference as listeners; their applications will be approved based on the order of receipt.

The individuals referred to in Sections a)-c) those who have registered for the Conference will receive an email from the Organiser informing them whether they have been qualified or not. ("Rules for Qualifying for Participation in the Conference")

13. Participant Limit: 160 ("Limit")

14. Withdrawal from participation in the Conference: by sending information to the Organiser at the following email address: jagiellonian.symposium@uj.edu.pl

15. Paid Conference - Conference participation fee ("Fee"):

a) Speakers and Passive Participants who pay the Fee by May 10, 2026 - PLN 2,500 (in words: two thousand five hundred zlotys),

b) Speakers and Passive Participants who pay the Fee after May 10, 2026 - PLN 2,700 (in words: two thousand seven hundred zlotys),

c) Speakers and Passive Participants who accepted the Organiser's invitation to participate in the Conference are not subject to the Fee,

- the date of payment of the Fee is the date of its receipt credited to the Organiser's bank account.

16. Conference language: English

17. The Conference will be financed from the Conference Fees and from funds from the Faculty of Physics, Astronomy and Applied Computer Science under the Excellence Initiative Strategic Program at the Jagiellonian University.

II. Submitting Papers ("Submission Rules"):

18. Types of conference presentations: lectures with an optional accompanying multimedia presentation or slide show, posters ("Submissions")

19. Rules for submitting applications for presentations:

a) method of submitting applications: the application form is available on the website: <https://indico.koza.if.uj.edu.pl/event/21/abstracts/>

b) type of submission: abstract - sending the original abstract of the presentation to the Organiser in the form of a digital text file

c) deadline for submitting applications: by May 30, 2026 ("Submission Deadline")

d) method of notification of qualification to present the presentation - by sending an email to the email address provided by the person submitting the abstract during the registration process

e) deadline for notification of qualification to present the presentation: by June 15, 2026

f) other: further contact to discuss the details of the Presentation will take place in a manner agreed upon by the Participant and the Organiser.

When selecting Presentations for the Conference, the Organiser uses their own discretion and the need to ensure a high scientific standard and thematic diversity

of the Conference. The Organiser's decision is final and does not require justification and is not subject to appeal.

III. Photo Report and Recording ("Principles of Sharing")

20. Rules for Sharing Photo Reports and Recordings:

- a. The Photo Report will be made available:
 - i. no later than 10 days after the end of the Conference, and will be made available indefinitely.
 - ii. to logged-in users of <https://indico.koza.if.uj.edu.pl> and logged-in users of LinkedIn.
 - iii. on the website <https://indico.koza.if.uj.edu.pl> and on the Organiser's LinkedIn profiles.
- b. The recording will be made available:
 - i. no later than 10 days after the end of the Conference, and will be made available indefinitely.
 - ii. to logged-in users of <https://indico.koza.if.uj.edu.pl> and logged-in users of LinkedIn.
 - iii. on the website <https://indico.koza.if.uj.edu.pl> and on the Organiser's LinkedIn profiles.

IV. Use of the Image ("Image Use Rules")

21. The image of a Participant, including a Participant who is a speaker, captured in a Photo Story and a Recording in connection with participation in the Conference ("Image") will be shared in accordance with the following rules:

- a. The Image will be published: on the website <https://indico.koza.if.uj.edu.pl>; individual photos may also be shared on the Organiser's LinkedIn profile.
- b. The Image will be published without each time identifying the Participant as the person depicted in the Photo Story and/or Recording, and without indicating their first and last name.
- c. The Image will be published: by the end of July 2026, indefinitely.
- d. The image will be made available to logged-in users of the website <https://indico.koza.if.uj.edu.pl> and logged-in users of the website LinkedIn.
- e. The image will be used until consent is withdrawn. Consent can be withdrawn by contacting the Organiser using the following details:

Part 2: Rules of Participation in the Conference - Regulations

§ 1

Date and Duration

1. These Regulations define the rights and obligations of Participants of the Conference, which will be held on-site on the Date and at the Location indicated in the Card.
2. A Conference Participant is any adult natural person with full legal capacity who, within the Registration Deadline, has expressed their willingness to participate in the Conference or accepted the Organizer's invitation to participate in the Conference, and has registered for the Conference in the manner referred to in § 2 of the Regulations, accepted the Regulations, and received information from the Organizer regarding their qualification to participate in the Conference (hereinafter referred to as the "Participant").
3. The Regulations are made available to Participants on the Conference Website in a manner enabling their downloading and playback without internet access.
4. The Organiser reserves the right to amend the Regulations due to changes in generally applicable laws and the need to adapt the Regulations to such changes, to enhance the security measures accompanying the Conference. Any amendments to the Regulations will take effect within 7 days of their publication on the Conference Website. For Participants who accepted the Regulations before the amendment, the amendment will take effect within 7 days of being notified of the amendment via email and not having objected to the amendment within the period.
5. The Organiser reserves the right to amend the Regulations even if the amendment does not adversely affect the Participants' rights or if the amendment involves correcting obvious clerical or editorial errors. In such a case, the amendment may take effect within a period shorter than 7 days, but no shorter than 3 days, of being notified of the amendment via email and not having objected to the amendment within the period.
6. The Organiser reserves the right to change the Conference Date and format if its conduct on the Date and format referred to in paragraph 1 above is impossible or excessively difficult for reasons beyond the Organiser's control. Any changes to the Conference Date and/or format will be announced immediately on the Conference Website.
7. The Conference Program is announced on the Conference Website. The Organiser reserves the right to update the Conference Program, including changes to the timetable and order of presentations. If any changes are made, the Organiser will immediately notify the Conference Website. A change to the Conference Program does not constitute a change to the Terms and Conditions.

§ 2

Conference Registration

1. Participation in the Conference requires prior registration by completing and submitting the Form available on the Registration Website.
2. Detailed registration procedures are available at Conference registration details, including the Participant Limit and the Rules for qualifying for participation in the Conference, are provided in the Registration Card.
3. The Organiser is not responsible for providing incorrect or false data when registering for the Conference.
4. The person who has registered for participation in the Conference will receive an email from the Organiser informing them whether they have qualified or not qualified for participation in the Conference.
5. The person registering for participation in the Conference via the Registration Form confirms that they have read the Regulations and accept the provisions of the Regulations, which is equivalent to granting the permits, licenses, and authorisations referred to in the Regulations. If the Conference is a paid event, registration also constitutes an obligation to pay the Fee. Registration for participation in the Conference is completed when the Participant's data is completed in the Registration Form and submitted via the system located on the Registration Page.
6. A person who has registered for the Conference acquires a place at the Conference upon receiving confirmation of their qualification for participation from the Organiser, and in the case of paid Conferences, upon payment of the Fee.

§ 3

General Rules of Participation in the Conference

1. Upon arrival at the Conference Venue, the Participant is required to confirm their presence at the reception desk.
2. To ensure safety at the Conference, the Organiser may use CCTV covering the entire Conference area and its individual sections. The principles for the use of CCTV by the Organiser are specified in Order No. 34 of the Rector of the Jagiellonian University of May 16, 2019, regarding the Regulations on Video Surveillance at the Jagiellonian University, as amended, available in the Jagiellonian University Public Information Bulletin.
3. Participants are required to comply with the safety rules, occupational health and safety regulations, and fire safety regulations in force at the venues where the Conference is held, as well as the sanitary rules in force at that time.
4. In the event of a Participant disturbing public order or failing to comply with the Rules and Regulations, Conference Staff are entitled to:
 - a) request the Participant to behave appropriately.
 - b) request the Participant to leave the Conference grounds.
 - c) call the appropriate services if the Participant's behaviour necessitates such intervention, if it poses a threat to other Participants, Conference staff, or the Organiser's property.

5. The Organiser is not responsible for incidents resulting from Participants' failure to comply with the Rules and Regulations, Participants' failure to follow the Organiser's instructions, or the instructions of Conference staff and services responsible for safety and order.

6. Participants accept the established rules and program of the Conference and undertake not to influence its changes or disrupt the Conference. The Organiser reserves the right to exclude from participation in the Conference Participants who violate the provisions of the Rules and Regulations, in particular:

a) disrupt the Conference.

b) engage in activities that are illegal, contrary to good practice, or that harm the legitimate interests of third parties.

c) engage in activities that attempt to circumvent or indicate an attempt to circumvent the Rules and Regulations or the rules of the Conference.

d) engage in activities that violate the legitimate interests of the Organiser or harm its image.

7. If a Participant notices a threat to the life or health of Participants, the Participant is obligated to immediately inform the Conference staff.

8. When providing Participants with conference materials (hereinafter referred to as "Conference Materials"), the Organiser emphasizes the need for Participants to respect intellectual property rights. Participants agree to use the Conference Materials provided to them by the Organiser solely for their personal use. Modification, copying, transmission, public performance, and any use of these Conference Materials for commercial purposes requires prior written consent from the Organiser or another authorised entity. Participants are fully liable for any damages resulting from their conduct contrary to the above provision.

§ 4

Presentations

1. A person registering for the Conference via the Form notifies the Organiser of their intention to deliver a Presentation in accordance with the Rules for Submitting Presentations described in the Card.

2. Compliance with the Rules for Submitting Presentations, including submitting an abstract of the Presentation (hereinafter referred to as the "Abstract") to the Organiser, constitutes a non-exclusive license, unlimited in time, territory, and quantity to use the Abstract, within the scope and fields of use referred to in § 4, paragraphs 5-8 of the Regulations, with the right to grant sublicenses to third parties with a scope analogous to the scope of the license, for the purposes of deciding whether a given person is eligible to deliver a Presentation, preparing, organizing, conducting, and settling accounts for the Conference, developing Conference Materials, including the book of Abstracts, and for the purposes of promoting the Conference and disseminating information about the Conference. The provisions of paragraphs 3, 4, and 9 of this section apply accordingly to

the Abstract. If a Participant submits an Abstract to the Organiser for a purpose other than the selection of applications, the provisions of this section apply accordingly.

3. The Participant qualified by the Organiser to deliver a Presentation and the person who accepted the Organiser's invitation to present the Presentation (each hereinafter referred to as the "Speaker") are fully responsible for the form and content of the Presentation. 4. The Speaker undertakes to develop and present their own Presentation and guarantees that the Presentation will not violate the rights and personal rights of third parties, nor contain theses or views that incite hatred or discrimination against any person based on race, culture, ethnicity, religion, worldview, or gender. Furthermore, it is prohibited to promote ideologies and symbolism associated with totalitarian systems in the Presentation, nor to present other topics prohibited by generally applicable laws, nor to harm the reputation of the Organiser.

5. If any part of the Presentation contains legally protected elements to which the Speaker does not have the rights, the Speaker guarantees that they are authorized to use them to the extent necessary to deliver the Presentation and to grant the Organiser the license with the right to sublicense referred to in this paragraph, without the Organiser having to obtain additional consents and permissions. 6. The Speaker grants the Organiser a non-exclusive license, unlimited in time, territory, and quantity, with the right to grant sublicenses of a similar scope, to use the Presentation in whole or in part, either individually or as part of a collective work, in combination with works and elements freely selected by the Organiser (including Presentations by other Speakers, images and sounds, including the so-called Conference Materials), as well as its compilations, adaptations, and all materials, graphics, fragments, shots, and documentation created in connection with the recording of the Presentation - for informational, documentary, educational, teaching, advertising, and promotional purposes of the Organiser and the Conference itself (hereinafter referred to as the "License"). 7. The license is granted to the Organiser upon presentation of the Presentation and covers the use of the Presentation in the following fields of use:

a) making it available on the Internet, as well as within any telecommunications services using any systems and devices, on any of the Organiser's profiles

on social networking sites, on the Organiser's websites, and on the Conference Website.

b) recording, permanent or temporary reproduction of the Presentation in whole or in part by any means and in any form using any available techniques.

c) with respect to dissemination of the Presentation, public performance, exhibition, display, reproduction, broadcasting, and rebroadcasting, as well as making the Presentation publicly available in such a way that everyone can access it at a place and time of their choosing, broadcasting the Presentation via a multimedia and IT network.

d) with respect to trading in the original or copies on which the Presentation was recorded – placing on the market, lending, or renting the original or copies.

e) creating and distributing derivative works of the Presentation, including further projects/materials based on the Presentation or its individual elements, and using

such derivative works within the scope and in all fields of exploitation specified in this section.

f) re-broadcasting, disseminating in the press, on the Internet, on large-format posters, and in all other forms of promotion or advertising.

g) modifying the Presentation in whole or in part and making derivative works thereof in whole or in part.

h) the right to freely use and exploit the Presentation and its individual elements, including using the Presentation and its individual elements for advertising, promotion, or University activities, both domestically and internationally.

8. The license also includes the Organiser's authorization to exercise and permit third parties to exercise derivative rights to the Presentation in all fields of exploitation specified in this section. 9. The Speaker agrees not to exercise his or her moral rights to the Presentation against the Organiser and entities authorized by him or her, in particular the right to inviolability of the content and form of the Presentation and its fair use – provided that such use is in accordance with the License; to decide on the first disclosure of the Presentation to the public; to supervise the manner of use of the Presentation; and to decide on the manner of attributing the author of the Presentation; provided that the Organiser, at the Speaker's request and to the extent possible, is obligated to respect the Speaker's wish to be designated as the person presenting the Presentation. 10. If third parties file claims against the Organiser and/or entities acting on its behalf and/or entities authorized by it to use the Presentation and/or Abstract (hereinafter collectively referred to as the "Authorized Entities") relating to the Presentation and/or Abstract or their individual elements, the Speaker:

a) will indemnify the Organiser and/or the Authorized Entities from the claims in question, to the extent that the Speaker was obliged to acquire from third parties the rights to legally protected elements of the Presentation and/or Abstract, including economic and related rights to them and their individual elements, the authorization to exercise and permit the exercise of dependent rights, and to obtain from them the permits and authorizations referred to in this paragraph, and

b) will be fully liable for any damages incurred by the Organiser and/or the Authorized Entities as a result of the claims referred to above being filed against them, including, in particular, but not limited to, damages related to claims for compensation for unlawful use of the Presentation and/or Abstract or unlawful use of their individual elements.

§ 5

Recording of the Conference

1. The Conference will be recorded in the form of a photo report (hereinafter referred to as the "Photo Report") and an audio-video recording (hereinafter referred to as the "Recording"), to which the Participant consents.

2. The Speaker consents to the recording of the Presentation by the Organiser or an entity acting on their behalf, in the form of a Recording and a Photo Report.

3. The Organiser will make the Recording and the Photo Report available in accordance with the Sharing Rules.

4. The Recording and the Photo Report will be used for educational, teaching, informational, documentary, advertising, and promotional purposes for the Organiser and the Conference itself, as well as for archiving purposes.

5. The license referred to in § 4 of the Regulations is also granted for recordings containing the Presentation or elements thereof.

§ 6

Image

1. By registering for the Conference, the Participant, including a Participant who is a speaker, consents, without time, territory, or quantity restrictions, to the use of their Image in accordance with the Image Use Rules.

2. The consent referred to in paragraph 1 above covers the use of the Participant's Image captured in a Photo Report and/or Recording.

3. The use of the Participant's Image may not occur for mocking, satirical purposes that may damage their good name or reputation.

4. The use of the Image includes the recording, processing, duplication, and multiple distribution of the Participant's Image captured in connection with participation in the Conference and in accordance with the Image Use Rules.

5. The Participant's image will be used solely in connection with the Conference – for educational, teaching, informational, documentary, advertising, and promotional purposes for the Organiser and the Conference itself, archiving, and as a Conference report, including in particular on the Conference Website, the Organiser's websites, the Organiser's social media profiles and websites, at the Organiser's promotional events, and in the Organiser's promotional materials indicated in the Image Use Policy.

6. In connection with the use of the Image, the Participant will not exercise the right to control or approve the use of the Image on a case-by-case basis, including the right to approve the final form of the Photo Report and/or Recording in which it was used, or the right to identify the Participant as a person depicted in the Photo Report and/or Recording.

7. The Conference may only be recorded by the Organiser. Participants are prohibited from recording or taking photographs during the Conference without the prior consent of the Organiser.

§ 7

Final Provisions

1. These Regulations are made available to Participants on the Conference Website in a manner enabling their download and playback without internet access and come into effect on the date of their posting on the website.

2. The presentation of the Presentation, as well as the granting to the Organiser of the License, permits, authorizations and licenses referred to in the Regulations (for the use of the Abstract, Presentation, and the Participant's image, including the Presentation's or Speaker's Image), within the scope and in all fields of use indicated therein, is free of charge and is for the statutory purposes of the Organiser, subject to separate agreements concluded with the Speaker.
3. Granting the Organiser the licenses, permits, authorizations, and licenses referred to in the Regulations is voluntary, but necessary for the presentation of the Presentation.
4. The Organiser will immediately notify the Participants, including Speakers, of the cancellation of the Conference on the Conference Website. The Organiser will not be obligated to provide any compensation or damages to Participants, including Speakers, for this reason, nor to reimburse any costs incurred to participate in the Conference, except for the reimbursement of the Fee, if the Conference is a paid event.
5. Subject to mandatory provisions, the law applicable to the Conference participation agreement concluded by accepting the Regulations is Polish law. In matters not regulated by these Regulations, applicable provisions of Polish law shall apply, the Civil Code and the Act of 4 February 1994 on Copyright and Related Rights.
6. Subject to mandatory provisions, all disputes will be subject to the jurisdiction of the Polish courts of general jurisdiction.
7. These Regulations have been drawn up in two language versions – Polish and English. In the event of any discrepancies in interpretation, the Polish version shall prevail.
8. The Conference Card is an integral part of the Regulations.
9. Information on the processing of Participants' personal data constitutes an annex to these Regulations.
